Confidential Settlement and Release of Claims and/or Complaints

This Confidential Settlement and Release of Claims and/or Complaints (the "Agreement") is made and entered into effect as of 09.03.2023 by and between Mango Group LLC, registration number of the company: 2080 LLC 2022, registered address: Firsts Floor, First St Bank Ltd Building, James Street, P.O. Box 1574, Kingstown VC0100, St. Vincent and Grenadines (hereinafter called the "Company") and Zeljko Lukasevic from Croatia, holder of Trading Account Number 120078, which is operated by the Company (hereinafter the "Trader"), the Trader and the Company shall hereinafter jointly referred to as the "Parties" and individually as the "Party" and,

WHEREAS the Company and the Trader wish to settle this dispute and/or claim between them in accordance with the terms stated hereunder.

THEREFORE, THE PARTIES AGREE AS FOLLOWS:

- 1. The Company, acting in good faith:
- Will provide the Trader's account (120078) with the amount of 14,000.00 EUR, and this
 amount will be transferred to the Trader's bank account.
- 2. That the Trader will withdraw and remove the Complaint submitted against the Company as well as remove any other claims and/or statements and/or videos publicly announced and/or posted on forums or any other public website online or offline against the Company.
- 3. In the case where a complaint has been filed by the Trader against the Company with any Regulatory Authority and/or any other competent authority, then this complaint should also be withdrawn by sending an email to the relevant Regulatory Authority and/or any other competent authority with the wording specified by the Company.
- 4. The Trader further acknowledges and agrees that the Company will perform its obligations under this Agreement, as specified in paragraph 1 (one) above, only after the execution of the terms of this Agreement and the fulfillment of the promises and/or obligations of the Trader as described in paragraphs 2 (two) and 3 (three) above.

- 5. The Parties agree that this resolution is reached without admitting liability for any claim and/or statement and/or complaint made by the Trader.
- 6. The Trader agrees to waive all claims, statements and/or complaints, referred to in this Agreement, against the Company and to release and forever discharge the Company from any and all liability for any claims and/or complaints and/or damages of any kind, whether or not presently known to the Parties, which the Trader may have against the Company as of the date of execution of this Agreement. Specifically, and without limitation, this release includes any claim arising under any federal, state, or local law or ordinance or equity, any tort, invasion of Confidential Settlement and Release of Claims and/or Complaints privacy, defamation, intentional infliction of emotional distress, injury to reputation, pain and suffering, constructive and wrongful discharge, retaliation, and any public policy which may be waived by law.

The Trader agrees not to sue, commence, voluntarily aid in any way, prosecute, or cause to be commenced or prosecuted against the Company any action, suit or other proceeding concerning the Complaint and/or any other claims and/or complaints, whether or not presently known to the Parties, in this jurisdiction or any other.

The Trader agrees that he will not make any negative or defamatory comments, openly demeaning or otherwise disparaging to the Company or any of its equity holders, directors, officers, traders, agents, successors, assigns, subsidiaries, or affiliates.
- 9. This Agreement constitutes the entire agreement between the Parties with relation to the subject matter hereof. Any prior negotiations or correspondence relating to the subject matter hereof shall be deemed to have merged into this Agreement and to the extent inconsistent herewith shall be deemed to be of no force or effect. The Company shall have no further obligations towards the trader other than the obligations included herein.
- 10. The Parties have read and fully considered the terms and obligations under this Agreement and willfully agree to be bound by it.
